However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.*

Consideration of establishing a tentative revenue and expenditure budget for the fiscal year beginning July 1, 2016 and ending June 30, 2017 pursuant to A.R.S. §48-853; declaring such for publishing and public notice; and setting July 12, 2016 at 6:00 p.m. local time for a public hearing prior to adoption (GCIFD #16-016).

Consideration of noticing the Maricopa County Board of Supervisors and the Maricopa County Elections Department the district will call for an election of board members on November 8, 2016 pursuant to ARS §48-252 and ARS §16-226.A; will use the Maricopa County Elections Department to conduct the election; and to direct staff to facilitate compliance with ARS §16-277, ARS §16-228 and ARS §16-229 as required for the election of district board members (GCIFD #16-017).
