Notice is hereby given to the general public that the Gilbert County Island Fire District (GCIFD) governing board will hold a meeting on Tuesday, May 9, 2017. The meeting will be held at the Southeast Regional Library – County Meeting Room, 775 N. Greenfield Road, Gilbert, AZ. The meeting will be open to the general public and will begin at 6:00 p.m. local time.

2. Consideration of appointing an interim member to vacant positions on the governing board pursuant to A.R.S. §48-852(B) (GCIFD #17-013).

4. Call to the Public.

A public body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.
5. Consideration of district financial matters:
 - a) Review and approval of monthly financial reports: March and April 2017 (GCIFD #17-014).
 - b) Review of invoices / payables and authorization for payment (GCIFD #17-015).
