However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

 - b) Review of invoices / payables and authorization for payment (GCIFD #17-035).
5. Consideration of retaining the firm of Accounting Professionals LLC for the purpose of performing an annual review of the district's financial records for the fiscal year ending June 30, 2017 pursuant to A.R.S §48-253. (GCIFD #17-036).
