The meeting will be open to the general public and will begin at 6:00 p.m. local time.

At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.*

Consideration of noticing the Maricopa County Board of Supervisors and the Maricopa County Elections Department the district will call for an election of board members on November 8, 2022 pursuant to ARS §48-852 and ARS §16-226.A; will use the Maricopa County Elections Department to conduct the election; and to direct staff to facilitate compliance with ARS §16-227, ARS §16-228 and ARS §16-229 as required for the election of district board members (GCIFD #22-018).
8. Consideration of items for the agenda of the Gilbert County Island Fire District's next regular scheduled meeting (July 19, 2022) and or a special meeting called by the governing board for the purpose of carrying out its powers and duties (GCIFD #22-019).
