However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

 - b) Review of invoices / payables and authorization for payment (GCIFD #18-003).
5. Discussion and possible action to retain Mr. Bill Whittington as the GCIFD legal counsel (GCIFD #18-004).
