

GCIFD Meeting Minutes – March 14, 2023

The Gilbert County Island Fire District (GCIFD) governing board met in a properly posted open public meeting on Tuesday, March 14, 2023. The meeting was held at the Southeast Regional Library – County Meeting Room, 775 N. Greenfield Road, Gilbert, AZ

- A. The meeting of the GCIFD board was called to order at 6:00 p.m. by Chair Biggs.
- B. Chair Biggs led those in attendance in the Pledge of Allegiance to the U.S. Flag.
- C. Roll Call: Chair Biggs, Clerk Mejia and Members Cazden, Farnsworth and Payne were in attendance. Chief Duggan - Gilbert Fire Chief, Kelly Vaughn - Administrator were also in attendance.
